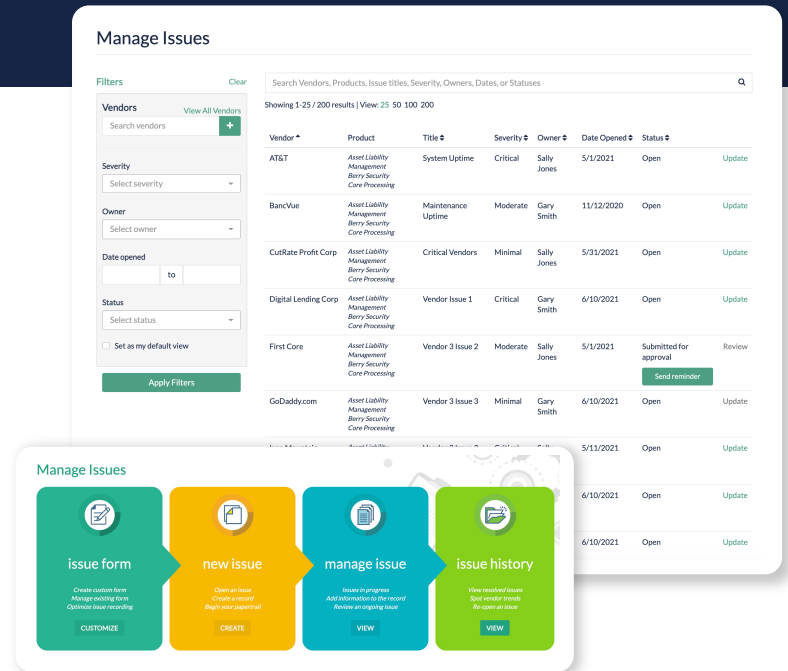
Issue Management

- manage issue**: Issue in progress, Add the response to the report, Review an ongoing issue, VIEW
- issue history**: View resolved issues, See vendor status, Re-open an issue, VIEW
